FEDERAL

2023 – IRC & 45W Expands Tax Credits based on weight of Commercial Fleet Vehicles –

- Up to \$7,500 Class 1,2 & 3 (if under 14,000 lbs.)
- Up to \$34,500 Class 4,5 & 6
- Up to \$40,000 Class 7 & 8

2023 – IRC & 30C – Expands the Alternative Fuel Refueling Property Tax Credit – Credit up to \$100,000 depends on U.S. Census address if Rural, Disadvantaged, etc.

Beginning January 1, 2023 - The Inflation Reduction Act includes a provision that provides non-taxable entities participating in clean energy incentives with a direct payment option in lieu of tax credits. This provision is applicable for tax years starting after December 31, 2022 and ending before January 1, 2033. Tax-exempt entities will be able to claim a refund for the excess taxes they paid or deemed to have paid. Please consult with a Tax Advisor to see if applicable.

Merchants does not currently take tax credits for EV purchases because our tax position does not allow us to take the benefit. However, Merchants can structure a specialized EV Master Lease Agreement that allows customer to take the tax incentives for a leased

MassEVIP Fleets Incentives – applicable for public K-12 schools and YES! You are not eligible for funding if you order the vehicle before you receive an approval letter from MassDEP.

MassEVIP. Yes - public entities, including public schools could be eligible for the MassEVIP Fleets Program. Up to \$7,500 per vehicle (purchase); Up to \$5,000 per vehicle for Lease! Interested applicants must complete the online application form at

https://massgov.formstack.com/forms/massevip_fleets_20 and submit it (with attachments) to MassDEP. • MassDEP will review the application for eligibility and completeness and will notify the applicant of the outcome of such review. • Upon review of a completed application, and subsequent favorable determination of incentive award, MassDEP will issue an Approval Letter and the End-User Agreement within 30 days of receiving the application. Applicants can order their EVs any time after receiving an Approval Letter from MassDEP

DERA – Diesel emissions reduction to replace buses - MD/heavy-duty vehicles – Not open at present (closed August 2022)


EPA has a Clean School Bus Program no open at present
