

Incentive Opportunities – Coppell, TX

FEDERAL

2023 – IRC & 45W Expands Tax Credits based on weight of Commercial Fleet Vehicles –

- Up to \$7500 – Class 1,2 & 3 (if under 14,000 lbs.)
- Up to \$34,500 – Class 4,5 & 6
- Up to \$40,000 – Class 7 & 8

2023 – IRC & 30C – Expands the Alternative Fuel Refueling Property Tax Credit – Credit up to \$100,000 depends on U.S. Census address if Rural, Disadvantaged, etc.

Merchants does not currently take tax credits for EV purchases because our tax position does not allow us to take the benefit. However, Merchants can structure a specialized EV Master Lease Agreement that allows customer to take the tax incentives for a leased vehicle provided customer qualifies for them, even though Merchants holds title to the asset.

STATE

Texas has several state grant programs through the Texas Commission on Environmental Quality (TCEQ) however none are open at present.

Governmental Alternative Fuel Fleet Grant Program – currently closed

Municipalities that operate a fleet of more than 15 motor vehicles are eligible. Priority in nonattainment areas that includes Dallas and Denton counties (see map next page).

TCEQ has established pre-determined grant amounts for the purchase or lease of new motor vehicles. Grant amounts per vehicle are provided below by vehicle class:

- Class 1 vehicles: \$15,000
- Class 2-3 vehicles: \$20,000
- Class 4-6 vehicles: \$35,000
- Class 7-8 vehicles: \$70,000

Diesel Emissions Reduction Act (DERA) Program – MD/HD vehicles - The U.S. Environmental Protection Agency established the DERA Program to reduce pollution emitted from diesel engines through the implementation of varied control strategies and the involvement of national, state, and local partners. DERA includes programs for existing diesel fleets, regulations for clean diesel engines and fuels, and regional collaborations and partnerships. 



